Dear WNSA Member or Interested Bowler,

We are kicking off our upcoming event at White Oak Lanes and hope for a great turnout. The event will take place over the weekend of July 9-10, 2011, at White Oak Lanes located in Silver Spring, Maryland. The Proprietor, Ralph Curry, has been a long-time supporter and is a member of our Hall of Fame.

The entry fee for this event is \$80.00. There will be two qualifying shifts held on Saturday, July 9th, at 8:30 a.m. and 1:30 p.m. In the past, we have had a very good turnout for White Oak and the afternoon shift has filled, so get your entries in early. **But, if we do not have 40 paid entries in-hand by June 30, we will hold only one shift at 10:00 AM and may not be able to accommodate late entries.** Therefore, we need your entries to be submitted before the deadline.

Bowlers must check in at least 30 minutes prior to their shift time. It is the bowler's responsibility to be there on time to avoid a penalty. Shift assignments will be made on a first-come, first-served basis using the entry's postmark. The semi-finals will start at 10:00 a.m. on Sunday. The Governing Body will meet at 8:30 AM on Sunday at White Oak Lanes.

Please complete the attached tournament entry form and return it to the address on the form. Do not return it to the WNSA office. Entry forms must be postmarked no later than Tuesday, June 28, 2011. Entries postmarked after this date will incur a \$10 late fee. **If we have do not have at least 40 paid entries by June 30, we will hold only a single shift at 10:00 AM.** This information and shift assignments will be posted on the WNSA web site.

Remember that we are fortunate to have a very generous anonymous donor who sponsors a \$100 cash drawing at each tour stop. All WNSA bowlers competing at this event are eligible. You could take home an extra \$100! The drawing will occur at the start of the final qualifying shift.

**Remember that you can bowl for FREE!** That's right, ZERO dollars! It is easy and some members are already doing this! See the sponsor materials in the FORMS section of the web site. With this program, entry fees are no longer an obstacle for any member.
